Me or my legal representatives are aware that by participating in the above event my physical health may be endangered, including a risk of being infected with the COVID-19 virus. I have weighed this risk and fully accept it by my participation in the sporting event. Furthermore, I relinquish the right to raise any claims on compensation against the operator of the sports facility or the organizer of the event e.g. in the event of such infection, if no there is no intentional or due to gross negligence.

I, as a participant, expressly acknowledge that the sporting event will be held in compliance with the provisions of laws, regulations, guidelines and decrees enacted to deal with the Corona pandemic, and hereby acknowledge that I am aware of all such legal provisions. Upon entering the event grounds, I undertake to comply with the legal provisions or the house rules and general regulations during my stay.

I acknowledge that the operator of the venues or organizer of the sporting event is entitled to monitor compliance with the above-mentioned regulations. In addition to the management of booking or access and tracking systems or recordings, this includes the acceptance of orders by personnel and video surveillance.

Furthermore, I undertake to immediately follow any instructions of the organizer of the sporting event or its appointed third parties to comply with the regulations. Otherwise an exclusion from the sporting event may be advised. In case of advice on exclusion from the event I must follow this exclusion immediately.

I confirm that I am not aware of an infection with the COVID-19 virus or have been in contact with any person infected with. Furthermore, I confirm that I am not currently in a legally required quarantine (even not at home or in the hotel or by arrival in another country). I do not belong to a COVID-19 risk group.

In the event of non-compliance with the COVID-19 regulations or a non-compliance of the content of this declaration of consent, I shall be liable to the organizer. I expressly agree that third parties can be used to ensure accomplishment with the above regulations

Accessing and participation of the event

To fully enable **contact-tracing** all athletes, team members and others will be registered compulsory **daily** at the accreditation desk.

The **daily** proof of a **negative test, vaccination or recovery in German or English** language allows accessing and participation of the event.

It is mandatory within the complete event area (indoor and outdoor) to keep 2 m Distance, FFP2 masks and ensure hygiene measures. Limited exception:

No mask from start of the race till end of the race (finishing line).

No 2 m distance after start of the race till end of the race (finishing line).

In the event of a positive COVID-19 test result, there is a legal obligation to report it to the Austrian authority.

Furthermore, the organizer may request the body temperature to be measured on site or the answer to questions about possible COVID-19 symptoms (cough, shortness of breath, taste and smell disturbance, sore throat, cold, diarrhea).

In certain cases, participants are required to keep a health diary prior to the event for a specified period of time and submit it to the responsible CORONA representative prior to the event.

Datenschutz

The following **personal data** are collected and processed for the following purposes: Name, birthday, phone number, e-mail address, address.

The basis of the data processing is Art. 6 para. 1 lit. c GDPR Compliance with legal obligations (COVID-19 emergency measures regulation) as well as Art. 6 (1) (a) GDPR Consent.

The purpose of the processing is the safe conduct of sporting events, i.e. the prevention of the spread of Corona Virus during the exercise of sports.

The data will be processed by the CORONA representative / the organisational team responsible for the event and stored for a maximum of 28 days. In some cases, it may be necessary to forward the data to a doctor for consultation in order to securely clarify the eligibility to participate.

There is no forwarding to other third parties, except notification to the authority in the event of a positive test result at the test.

You have the right to access, rectification, erasure and restriction of the processing of your personal data and can revoke your consent at any time in writing at the address below. However, in the event of a cancellation, participation in the event is not possible.
